

HMH READ 180 20th Anniversary Oculus Go Sweepstakes II Official Rules
("Official Rules"); No Purchase Necessary

- 1) **Sponsor.** The HMH 20th Anniversary Oculus Go Sweepstakes (the "Sweepstakes") is sponsored by Houghton Mifflin Harcourt Publishing Company, 125 High Street, Boston, MA 02110 ("HMH") and subject to these Official Rules.
